**Subject- To follow the guidelines in respect of Covid-19 Pandemic-regarding.**

Sir/madam,

With reference to the subject mentioned above, I am directed to inform you that, due to resurgence of COVID-19 infection across the country, Board of Governors in its 26<sup>th</sup> meeting held on 30.04.2021 decided to circulate following guidelines for implementation by all Ayurveda/Unani/Siddha & Sowa Rigpa colleges in respect of Covid-19 Pandemic.

### Guidelines

#### **TEACHING & RESEARCH -**

- The ASU colleges may opt for online teaching as per covid situation & after consultation with the affiliated university. Tentative Teaching schedule of Online Teaching Classes should be prepared by the institutions & submitted to the council for approval.
- In ASU institutions, the desertation work at PG level should focus on different aspects of Covid-19 situation.
- Research should exclusively be focused on COVID pandemic.

#### **HOSPITAL SERVICES -**

- Necessary steps may be taken for wide dissemination of AYUSH-64 as mentioned in "National Clinical Management Protocol based on Ayurveda and Yoga for Management of Covid-19" and Guidelines for Ayurveda and Unani Practitioners for Covid-19 patients for home isolation" issued by M/o AYUSH and the same may also be made available in their hospital.
- Covid-19 Guidelines issued by Ministry of AYUSH should be circulated to all ASU colleges. As per the guidelines of the state government, integrated approach for treating the covid patients may be opted. All ASU colleges/Institutions should follow and implement these guidelines.
- If ASU colleges/hospital has been acquired by the State / Central Government for Covid-19 pandemic, College authority should inform CCIM with their official letter alongwith details of admitted covid patients. A weekly report be submitted to CCIM on every Monday positively.
- Online consultation & OPD services may be started by ASU colleges as per Covid-19 situation. Covid-19 Helpline number be issued and publicized by every ASU College Hospitals for consultation. A weekly report of Telemedicine and online consultation be submitted to CCIM on every Monday positively.
- Revised tele-medicine guidelines prepared by M/o AYUSH will be circulated to the colleges for implementation. All teaching institutions may start online OPD & consultation as per telemedicine guidelines.
- Success stories ASU College Hospitals in managing COVID-19 be reported and submitted to CCIM.

#### **AWARENESS INITIATIVES -**

- All Ayurveda/Unani/Siddha colleges are requested to Co-ordinate with State/District/Local authorities for considering their available hospital facility as Covid Care center(CCC)/ Covid health care (CHC).
- ASU colleges may participate in Covid-19 vaccination program with due permission from the local authorities

- ASU colleges should utilize their resources, to create awareness of Covid-19 pandemic. Special awareness campaigns against COVID-19 be started by all ASU College Hospitals and Counseling Centres.
- ASU colleges should register helpline number for Covid-19 pandemic to help the general population in their vicinity.
- Services of the professional counsellor or Manas Roga expert may be hired by ASU colleges for psychological counselling of the nearby population.
